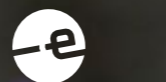

Dimensions of innovation

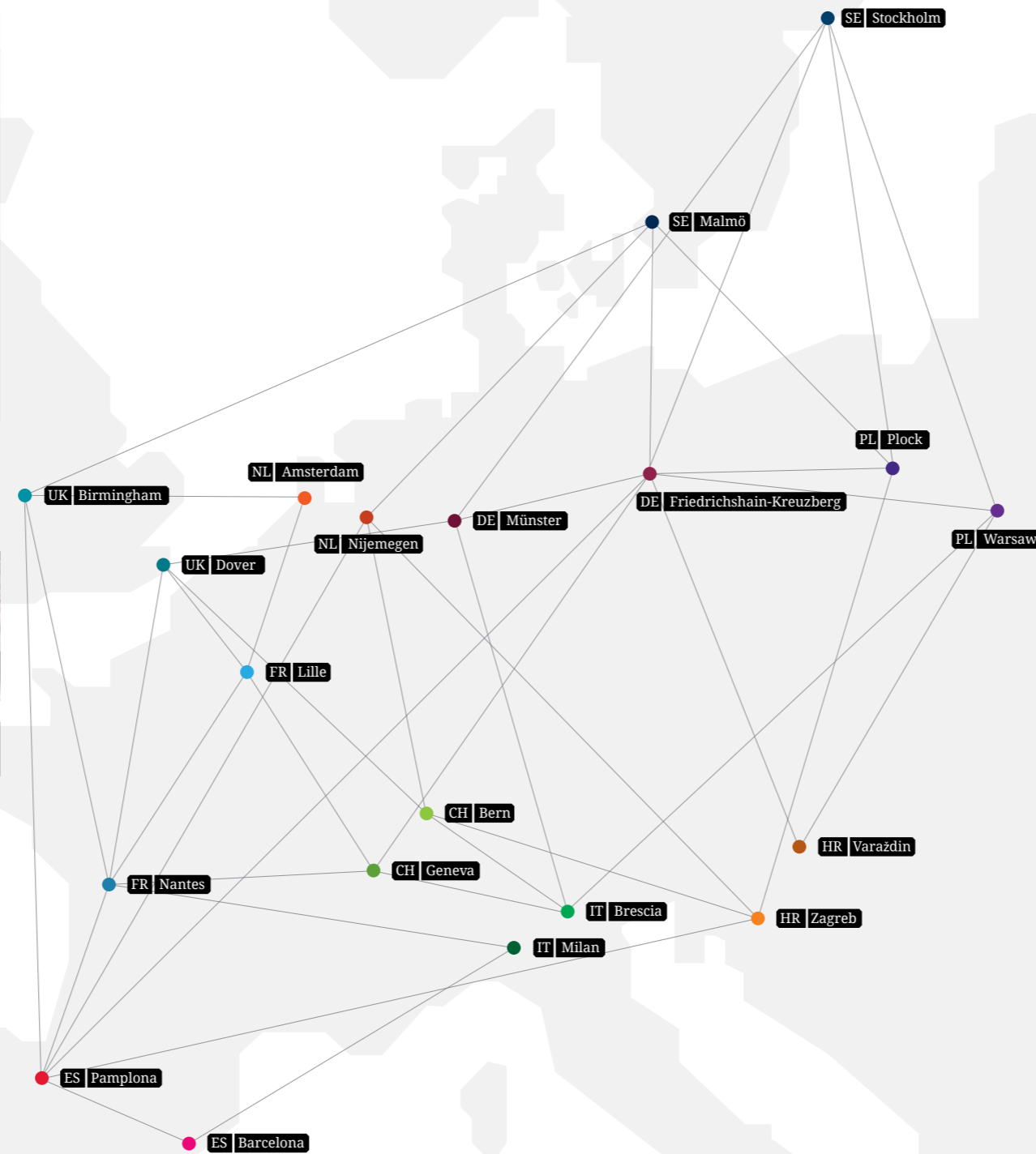
- Service innovations
